Expansion/Implementation of Mandatory Electronic Filing – 6th Judicial

District

I am pleased to provide the Bar and other interested persons with an update on the progress of the New York State Courts Electronic Filing System ("NYSCEF"). To date, the 6th Judicial District has successfully implemented e-filing programs in the Supreme Court in all counties within the District. At this time, the District Administrative Judge of the 6th Judicial District has proposed the following: to expand the current mandatory e-filing program in the Broome County Supreme Court, and to implement mandatory e-filing programs in the Supreme Court of Chenango, Madison, Schuyler, and Tioga Counties. The County Clerk of each County has joined in the request. It is expected that the proposed programs will take effect on **May 26**, **2021.** As a result of the requested expansion/implementation, there will be a mandatory e-filing program in the Supreme Court of each of the 10 counties within the 6th Judicial District.

As of the effective date, the authorization will be to <u>implement a mandatory e-filing</u> <u>program</u> in the Supreme Court of **Chenango**, **Madison**, **Schuyler**, **and Tioga** Counties, and to <u>expand the current mandatory e-filing program</u> in the Supreme Court of **Broome** County, to <u>include all new civil actions</u>, <u>except</u>:

- CPLR Art. 70 proceedings
- CPLR Art. 78 proceedings
- Election Law proceedings
- matrimonial matters
- Mental Hygiene Law matters
- consumer credit transactions as defined in CPLR 105(f)*
- residential foreclosure actions as defined in RPAPL 1304*
 (*except initial filing of commencement papers by a represented party, which is mandatory)

Additionally, each of the existing consensual programs will be modified to include the case types listed above that are not subject to mandatory e-filing, and will include the consensual e-filing of documents filed subsequent to commencement papers in consumer credit transactions and residential foreclosure actions.

Persons wishing to comment on this proposal should e-mail their submissions to <u>efilingcomments@nycourts.gov</u> no later than May 22, 2021. A new page has been created on the Unified Court System's website - <u>www.nycourts.gov/rules/efiling/</u> - to provide notice to the public of proposed new or expanded mandatory e-filing programs and for posting any public comments received on such proposals. Attorneys, paralegals and interested filers may register on-line for upcoming training sessions.

Please note that by legislation and statute all unrepresented parties are automatically exempt from participating in e-filing in any case. However, unrepresented parties may choose to e-file. Information on how to do so is available at http://www.nycourts.gov/e-file-unrepresented. Attorneys who certify in good faith that they lack requisite hardware, electronic connection, or technical knowledge to participate in e-filing, may opt out of e-filing.

E-filing represents an important and necessary advance for the courts and the legal profession in New York State, and the current public health emergency has heightened the importance of these invaluable programs. We thank you for the wonderful support and cooperation you have shown and look forward to continuing to work closely with you as the program continues to move forward.
